

Rules and Entry Forms for "NCC 2017 Juried Exhibition"

RULES

1. The "Nevada Camera Club 2017 Juried Exhibition" (hereafter referred to as NCC Exhibition) is open to all Nevada Camera Club members whose dues are current as of the time of entry acceptance.
2. Entries which have appeared in a prior Best of NCC or NCC Juried Exhibition are not eligible.
3. A maximum of six (6) prints may be entered by any member. There is no entry fee.
4. Entries may be either monochrome or color. There are no categories.
5. Entered photographs must have been exposed by the submitting member. There is no time frame during which the photographs must have been taken. However, members are encouraged to enter recent work.
6. Entries submitted for judging/selection to the NCC Exhibition may be in their original mattes/mounts and of a size less than 16" x 20". However, any photograph selected into the NCC Exhibition must be brought into compliance with the requirements in rule 7 and returned to the Exhibition Chairman on or before December 1, 2017. All entries must be printed on photographic paper. Alternative materials including but not limited to wood, metal or acrylic, for example, are not acceptable.
7. Presentation guidelines have been established to insure uniformity of the framed photographs since the NCC Exhibition is a gallery exhibition. NCC Exhibition selections must be mounted on exactly 16" x 20" flat rigid board, either vertically or horizontally. They may be single or double matted with beveled edges. No flush mounts. All mattes and filets must be in white or black only. No color mattes or filets as this is a gallery exhibition. The specific shades of white or black used is the choice of the photographer. No creams or ivories.
8. Standard NCC monthly competition rules apply with respect to print size.
9. Each print selected shall be framed by the Nevada Camera Club for exhibition. The frames will be removed before the prints are returned to the photographers. Do not enter framed prints.
10. The selection of the NCC Exhibition will be juried by professional and/or fine arts photographers. The decision of the judges is final. The photographs selected for the NCC Exhibition should not be considered as winners but should be considered as selections representative of the best photographs of the Nevada Camera Club members for the year.
11. Photographs may be entered on October 27, 2017 from 4:30 PM to 6:30 PM (before the start of the NCC General Meeting) at Sunrise Hospital Rendezvous Room, 3186 S. Maryland Parkway, Las Vegas, NV 89109.
12. The selected prints will be exhibited at the Enterprise Library, 25 E. Shelbourne Ave., Las Vegas, NV 89123 beginning on November 30, 2017 and continuing through February 6, 2018.
